- 6 are new potential investors \$320,000 in five year requests

### Of the 155 Committed Investors:

- 19 are new program investors
  37 renewing investors increased their investment
  74 renewing investors reladeed the same emperator
  74 renewing investors are also and the same emperator
- 74 renewing investors pledged the same amount 48%
- 25 renewing investors decreased their pledge amount 16%

### 51 campaign prospects declined to invest

- 11 were previous Alliance investors representing \$167,500/ 5 years
